Out of the approximately 13,000 cleared facilities nationwide, less than 1% (61) received Cogswell awards this year. Facilities may be nominated for the award only if they have a minimum of two consecutive, superior security ratings and show a sustained degree of excellence and innovation in their overall security program management, implementation and oversight.
