Know all by these presents, that the undersigned hereby constitutes and appoints each of the Chief Financial Officer, the Controller, and the Chief Legal Officer of Mercury Computer Systems, Inc. (currently Robert E. Hult, Stephen Sarno (interim), and Gerald M. Haines II), acting singly, the undersigned's true and lawful attorney-in-fact to:
